

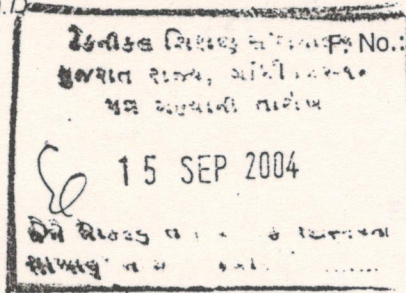



No Management, Institute, Trust or Society shall announce admission directly under any circumstances. Any action contrary to this provision taken by the Institute will make it liable to be derecognised.
